### 1. Police Report

PC GG advised that there were 23 incidents between 04 Dec and 10 Jan 2020:

### 3. Minutes of the Previous Meeting

### 4. Matters Arising

*Community Councils Consultation Phase 2 - Community Council Scheme Handbook – deadline now 7 February 2020.*

Secretary attended (very briefly) a meeting in Maybole, however was unable to fully participate. Another meeting is being held on 4 February in Girvan – Secretary to attend, after re-looking at the new Scheme, as there seems to be a total change of the Handbook rather than just the points raised in SAC email.

### *Christmas Tree*

Secretary sent Thank You email to Bargany, and will thank McWhirter for installing the Tree. Members commented that it would be good to have a Christmas Tree annually, as having it produced good response and community spirit. Maybe to expand to include a light switch-on ceremony/get-together – Members to think about it and remember for this year – talk about it again in September. Members also had other thoughts on Community involvement around Hogmanay.

### *Roads / Potholes / Gully Pots / 20 mph consultation*

Nothing much had happened over the last period – some of the potholes in the area have been filled, but the general feeling is that the roads have deteriorated quite badly. HD would put the ARA reporting information on Facebook, as a reminder that members of the public should report any road incidents – potholes, flooding, ditches, etc.

### *Daily Trails / SAPI*

The Wooden Bridge not sure if this has been fixed. FdF noted that we still have to organise the work/volunteers for the Paths for All grant. They will be asking for update – due to weather/conditions, nothing has been done. RT advised that by the Metal Railway Bridge a tree had come down and partially removed, also a coping stone had been dislodged – presume ARA/Railways would sort this.

### *Windfarms – General*

Per headings below, as a reminder:

Linfairn – no new info.

Tralorg – not sure yet whether the WF has been energised.

Lamboughty – no further info.

Kirkhill – planning extension granted to 2022.

Kilgallioch – Understand that an extension is being scoped.

Chirmorie – passed for 22T

Altercannoch – refused on appeal for 8T by reporter.

Millenderdale – has gone to appeal for 5T.

Glenapp and Arecleoch extensions – application for 22T is to join up the two windfarms.

Mark Hill substation extension – does this mean more turbines?

Hadyard Hill – turbine number 44 or 45 has been removed.

Clauchrie – EIA is available to view in Barr or Barrhill Community Halls – planning application number with the Energy Consents Unit is: ECU 00002001.

Secretary had a meeting with a few residents of Dailly, Barr and Barrhill who were concerned about the implications of Clauchrie Windfarm. It is understood that there will be 18T upto 200m high – enormous. It was felt that should this windfarm with such big turbines be allowed to proceed, then this would be an opening for further Extensions to existing windfarms and potentially new windfarms. SAC had already agreed previously that South Ayrshire has had its fair share of windfarms. Secretary presented various documentation for discussion and members agreed that as a community council we should object to this windfarm. If individuals wished to make representation they should do so.

**If members of the community have any comments regarding proposed windfarms, they should make their views, whether positive or negative, known to the CC as soon as possible, or direct them straight to the planning application.**

*Community Centre WiFi*

It was understood that the WiFi is still not properly sorted – waiting for a booster. Hoped to be fixed by February 6 when there is an Employability Skills Drop-in.

*McColls Loading Bay*

PW will continue to monitor.

*Galloway and South Ayrshire Biosphere*

FdF would be progressing the Friend application after becoming a Supporter.

*VE Day 75 – 8-10 May 2020*

It appears that SAC have not changed the bank holiday from 4 May to take account of the VE Celebrations. Secretary to ask what is happening.

5. Carrick Activity Centre

HM advised that Access to Leisure Scheme was being used with 15, 25 and 50% discounts being utilised – trying to encourage more people to use the Scheme and become members.

6. Hadyard Hill Community Fund Panel/Review and Small Grant Fund

Clare Graham/FS had sent a draft poster for the new Dailly Panel – there were several comments, mainly to ensure that it emphasises Dailly and asking for people to help make the decisions, and to be more straightforward. Maybe extend the date, and not so many leaflets required. Relevant documentation still being worked on.

There was one application for the Small Grant Fund – Dailly Amateurs FC were asking for £500 towards upgrading the building and outside paving. Unanimously agreed to support.

7. Brunston Castle

The property had been sold, exchanged on 20 December 2019.

8. Locality Planning / Participatory Budgets / H&SCP

JW and Secretary had been unable to attend the January meeting. Secretary would try to attend on 12 February. Various notices had been put on FB and on the Notice Boards.

9. Councillor's Report

Cllr AC was not in attendance due to illness.

10. Any Other Business

*Dalquharran Forest Long Term Forest Plan* – had received a letter from DGA Forestry LLP re 10 year management of the woodland – there do not appear to be any issues however need to make sure that the extraction routes are not going to impact the Village.

*Litter* – There had been a litter pick-up on Sunday 25 January where 23 bags of litter were taken to Girvan Coup. Members thought there should be another one on Sunday 1 March at

*Broken Bench at Brunston Entrance* – Secretary to advise SAC about broken wooden slats.

*NHS Ward 15 Chemotherapy Consultation* - There is a consultation re the possible closure or removal of certain therapies at Ayr Hospital – Members thought that we as a CC should object to anything that was detrimental to service for South Carrick - individuals are also encouraged to respond to this and other surveys.

*Coronavirus* – Question was asked re SAC's preparedness.
