Windfarms – General

A new windfarm is being proposed:

Carrick near Garleffin Fell and the Pilot – 17T up to 200m in height – Scottish Power Renewables have sent a letter, as far as we are aware we have had no previous communication from them re a windfarm, only re a mast. Energy Consents ref: ECU00002063.

Per headings below, as a reminder:

Arecleoch Extension – 13T plus associated infra – refused by SAC.

Linfairn – no new info.

Tralorg – BayWa r.e. ceased construction on 24 March due to Covid-19, they will resume on 11 May under Covid Safety Measures.

Lamboughty – no further info.

Kirkhill – planning extension granted to 2022.

Kilgallioch – Understand that an extension is being scoped.

Chirmorie – passed for 22T

Altercannoch – refused on appeal for 8T by reporter.

Millenderdale – has gone to appeal for 5T.

Glenapp – no additional info.

Mark Hill substation extension – does this mean more turbines?

Hadyard Hill – turbine number 44 or 45 has been removed.

Clauchrie – our objection was submitted 27 February to the Consents Unit: ECU 00002001.

If members of the community have any comments regarding proposed windfarms, they should make their views, whether positive or negative, known to the CC as soon as possible, or direct them straight to the planning application.

Galloway and South Ayrshire Biosphere

The Biosphere has sent out a business survey.

Dobbingstone Forest Long Term Forest Plan

Communication is on-going with Mark Hamilton Landscape Services on behalf of the owners. Water supply and contamination, access and EIA report are the main issues.

#### Litter and Grass Cutting

Various people have been generally litter picking and some people have very kindly cut the grass in certain areas – THANK YOU ALL VERY MUCH. There have been complaints of heavy dog fouling, especially on pavements and paths.

#### Bargany / Brunston

Brash and additional larch is still being taken out, re-planting of site – on-going process. Both sides of the river will be stocked with either sheep or cattle at various times/rotation.
