*Roads / Potholes / Gully Pots / 20 mph consultation*

The B741 between Rowanston and Aird Bridge is being resurfaced commencing 20 July for 6 weeks. Diversions in process, working between 0800 – 1700 hrs Monday to Friday. A member of the public has asked about having a one-way system at Hadyard Terrace – will investigate again with ARA.

Still working on getting the old stiles along the River/Barony Trail renewed, and using the Paths for All Grant to install self-closing gates elsewhere.

Dalquharran still has forestry work being carried out. Please continue to take extra care regarding tree felling - do **not** enter the area, and take note of signage. Plans are moving forward regarding pathways and eventually a pond, but progress is slower than anticipated.

### *Wind Farms – General*

Per headings below, as a reminder:

**Craiginnoddie** – 16T upto max 230m in height – basically in area of ex-Hadyard Hill Extension – Energie Kontor – ECU00002080 – scoping response sent 20 July.

**Carrick Forest** – 17T upto 200m high – ECU00002063 – in scoping, SPR, leaflet has been sent out, a larger map on Notice Board, a response has been made for the Scoping. SPR asking for any input re Recreational Enhancements.

**Arecleoch Extension** – 13T plus associated infra – refused by SAC, SPR resubmitting.

**Kirk Hill** – planning extension granted to 2022 – requesting an increase in height from 110 to 115.5m – appealing Energy Consents Unit – PPA-370-2086.

**Clauchrie** – our objection was submitted 27 February to Consents Unit - ECU 00002001.

**Tralorg** – BayWa r.e. – construction resumed 11 May, not yet energized.

**Lamboughty** – no further info.

**Linfairn** – no new info.

**Kilgalloch** – Extension being scoped.

**Chirmorie** – passed for 22T – renewal of planning permission per planning below

**Altercannoch** – refused on appeal for 8T by reporter.

**Millenderdale** – SAC refused for 5T.

**Glenapp** – no additional info.

**Mark Hill substation extension** – does this mean more turbines?

**Hadyard Hill** – turbine number 44 or 45 has been removed.

**South Kyle** – approved.

**Artfield Forest** – 20T 180m in height, in scoping adjoins existing Artfield near New Luce – Scottish Power Renewables (SPR) - ECU00002042.

**If members of the community have any comments regarding proposed windfarms, they should make their views, whether positive or negative, known to the CC as soon as possible, or direct them straight to the planning application.**

### 3. Hadyard Hill Community Fund Panel/Review and Small Grant Fund

Current funding round for the Main Fund closed 31 July with Panel meeting in September.

Next round deadline is 31 October with Panel meeting in December – applications at:

Small Grants Fund – CC recently approved, by majority, an £500 application from Dailly Amateurs for netting and flags, with the proviso that best value is used.

### 4. Treasurers Report

Recently paid £40 to the Information Commissioner as required under GDPR.

Balance in CC Account as at 25 July - £13,255.90

Of this £5,308.97 is HHBF Small Grant Fund. We will receive a further £5,000 (20/21 SG award) when this balance falls below £5,000 – so applications to this fund should continue to be encouraged.

Dailly CC Development Account balance is £1,501.56 – of this £1,500 is the Paths for All Grant allocated to self-closing gates/path improvements in line with initial application.
