1. Police Report

2. Matters Arising

Roads / Potholes / Gully Pots / 20 mph consultation

The B741 is now open and is so much better. There is now another resurfacing work on the B734 between Old Dailly and Barr from 7 September for 3 weeks. Diversions in process, road closed between 0930 – 1530 hrs Monday to Friday.

Dailly Trails and Dalquharran

SAC is awaiting quotes for various works relating to sections on the Barony Trail – stiles and boardwalks. They are also awaiting a quote for filling in the 'lake' on the Drovers Road between Balcamie and Whitehill. Still investigating where to install self-closing gates using the Paths for All Grant. Waiting for SAC to advise about strimming/clearing the River path around the Memorial Park.

Dalquharran still has forestry work being carried out. Weather has slowed any progress.

There has been an article on the SAC website/News section that funding will be available for Dailly and Barr for new paths. Secretary is investigating this with the help of Cllr AC. There has been no consultation yet, will update as soon as more info is available.

Wind Farms – General

Per headings below, as a reminder:

Craiginmoddie – 16T upto max 230m in height – basically in area of ex-Hadyard Hill Extension – Energie Kontor – ECU00002080 – scoping response sent 20 July.

Carrick Forest – 17T upto 200m high – ECU00002063 – in scoping, SPR, leaflet has been sent out, a larger map on Notice Board, a response has been made for the Scoping. SPR asking for any input re Recreational Enhancements.

Arecleoch Extension – 13T plus associated infra – refused by SAC, SPR resubmitting. **Kirk Hill** – planning extension granted to 2022 – requesting an increase in height from 110 to 115.5m – appealing Energy Consents Unit – PPA-370-2086.

Clauchrie – our objection was submitted 27 February to Consents Unit - ECU 00002001 (ref 074). Have received advice that SAC has formally objected.

Tralorg – BayWa r.e. – still not fully energized, but nearing completion.

Lamboughty – no further info.

Linfairn – no new info.

Kilgallioch – Extension being scoped.

Chirmorie – passed for 22T – renewal of planning permission.

Altercannoch – refused on appeal for 8T by reporter.

Millenderdale – SAC refused for 5T.

Glenapp – no additional info.

Mark Hill substation extension – does this mean more turbines?

Hadyard Hill – turbine number 44 or 45 has been removed.

If members of the community have any comments regarding proposed windfarms, they should make their views, whether positive or negative, known to the CC as soon as possible, or direct them straight to the planning application.

Dobbingstone New Woodland Creation Proposal

Not all documentation had been received in time for deadline. New deadline of 21 September. A response is being worked on with those involved in the specific area.

Newlands Woodland Creation Proposal

Response to consultation document sent 04 September, after obtaining additional info.

3. Hadyard Hill Community Fund Panel and Small Grant Fund

The Panel will have their first meeting towards the end of September re the funding round that closed 31 July. Next round deadline is 31 October with Panel meeting in December – applications at: www.foundationscotland.org.uk/programmes/hadyard-hill-dailly/.

Small Grants Fund – there have been no applications.

4. Treasurer's Report

Balance in CC Account as at 04 September - £13,640.69. Received £344.79 from SAC to cover 2019/20 admin costs. Small Grant Fund balance within this account is - £5,308.97. We will receive a further £5,000 (20/21 SG award) when this balance falls below £5,000 – so applications to this fund should continue to be encouraged.

Dailly CC Development Account balance remains at £1,501.56.

5. Councillors Report

Cllr AC is investigating the New Paths issue as above.

He has been working with SAC re guidance on how to proceed with physical meetings – there is a slight possibility that we can have a proper meeting in October (will advise asap). He also advised that SAC had formally objected to Clauchrie Wind Farm.
