This round of the Touring Fund - for outdoor and non-conventionally staged work - is specifically designed to respond to the limitations in place within the dance, theatre and touring landscape, as a result of the coronavirus pandemic and associated restrictions. This round of the fund therefore seeks to support venues, theatres, artists, companies and producers to present shows that will allow them to re-engage with their audiences in innovative ways while still complying with ongoing restrictions during 2021.</p> <p>When should the funded touring activity to take place? Due to current COVID-19 restrictions and the high level of uncertainty that currently exists, Creative Scotland (CS) appreciate that forward plans for touring need to be flexible. Current restrictions forbid all public gatherings, but it is likely that there will be potential for some kind of live performance presentation at some point in 2021. Longer term restrictions on numbers, social distancing and settings will inevitably continue to apply for some time.
