4. Wind Farms – General

Per headings below (have taken away ones that have not been updated recently): Clauchrie – Consents Unit - ECU00002001 (ref 074). SAC formally objected. Now going to Public Inquiry – DPEA – WIN-370-3 – it will be possible to watch the proceedings. Craiginmoddie – amended to 14T upto max 200m in height – basically in area of ex-Hadyard Hill Extension – Energie Kontor – ECU00002080 – on-line public event available - https://www.energiekontor.co.uk/our-projects/craiginmoddie - please advise if you have any comments.

Carrick Forest – reduced to 13T upto 200m high inc Energy Storage System – ECU00002063 –scoping response sent. Recreational Enhancements indicated, and Online Public Information Event held. SPR have now sent info re Community Investment if consented to build. This needs to be discussed/consulted on. SPR sent a 'Gatecheck Report' in response to our EIA Scoping response. Various Questions answered.

Arecleoch Extension – 13T plus associated infra – now going to Public Enquiry – hearing from 11 January into February.

Kirk Hill – planning extension granted to 2022 – appeal granted height now 115.5m. **Tralorg** – operational since 21 October. *Fund meeting 02 Dec to discuss distribution and operation of fund.*

Knockodhar – 32T tip height upto 200m inc Energy Storage System. South side of Stinchar Valley. *In Scoping ECU00002153 – sent response 27 November.*

Flyer/leaflet has been sent out to all households in the Dailly Parish – distribution in the Village was carried out by PW, FdF, SN and Neil Bannatyne – thank you. The outlying residents received by post. Response is requested by 9 December.

Per planning below, more applications for either windfarms, met masts or grid upgrades.

If members of the community have any comments regarding proposed windfarms, they should make their views, whether positive or negative, known to the CC as soon as possible, or direct them straight to the planning application.

5. Paths / Dailly Trails and Dalquharran

Rachel Shipley/SAC advised - Kilgrammie broken board walk replaced with culvert, Balcammie Drovers Road has been filled in with hard core, the Stiles along the fields at the River Walk have been repaired and now have dog gates, the River Walk leading to the Fish Bridge has been strimmed and the Fish Bridge will be cleaned off and the vegetation taken away from under and through the structure. Poundland repairs are weather dependent; it has been difficult to access the site with materials – this will probably wait until Spring now. JF is advising on the size and location of the self-closing gates on the Poundland section of the Barony Trail; will then get quotes for installation.

Secretary advised Alex Paton about the suggestion that was put forward at the last meeting re the damaged bridge at Gigmagog/Drumburle and the previously proposed path along the river returning to Dalquharran – he would like to investigate possibilities. AP advised that Forestry works will stop until Spring; they were concerned about the mess being created while working with the weather conditions experienced over the past couple of months. If the conditions change some reinstatement work might take place. The Heras fencing at the Bridges has been uplifted.

We should now seriously think how we can best use our portion of the £25,000.

Secretary has co-ordinated with ARA to have certain lights upgraded or bulbs changed.

9. Councillor's Report

Cllr AC indicated that he would remain as our Councillor in rotation until the next elections in March/April.

Cllr AC attended the SAC/ARA meeting last month and approval was granted for the 20 and 30mph speed limit road improvement to go ahead. Planning should be approved in the not too distant future. He indicated that the Hadyard Terrace one-way proposal was being investigated. The road between Dailly and Old Dailly is scheduled for resurfacing in the 21/22 budget. A member pointed out that the Back Road was in a shocking state due to services/patching – Cllr AC would make this known to ARA.

10. Other Points

Illegal Parking on Pavements - there has been a complaint made about the amount of illegal parking on pavements preventing access to pedestrians, restricted mobility and prams – particularly the corner of Wood Street, at the top of the Hill at Coleman's Garage, and also at Hadyard Terrace. Cllr AC would advise ARA.

Miners Memorial – on-going. Secretary to coordinate with Cllr AC.

Christmas Lights – Pauline Eaglesham indicated that the lights should be installed on Friday. JW indicated that he would request a Christmas Tree from Bargany.
