Notes from Wednesday 03 March 2021 Zoom Meeting at 7pm together with general input

3. Police Report

4. Wind Farms – General

Held a Zoom meeting 24 February – attended by CC, Cllr AC, and Allan Dorans MP. Ranging discussion re the way forward re windfarms in general and Craiginmoddie particularly. Besides the saturation of the area, turbine size, various Environmental/Residential impacts, one of the most important issues is lack of consultation in all respects. Email had also been sent to all South of Scotland MSPs – waiting for responses, though Paul Wheelhouse MSP had responded. AD had indicated possibly involving local newspapers – ET and FdF advised that they could participate. Secretary to continue contact with AD. Cllr AC advised that he had been in contact with Alan Edgar/SAC Planning re DCC concerns. Also advised that he will check Legal re his participation/position. He had also advised Girvan CC of the situation, so that they were aware of what is happening in the area.

Per headings below (have taken away ones that have not been updated recently): **Knockcronal** – in Scoping – ECU00002181 – *deadline extended to 3 March* – *put in response*. Basically ex-Linfairn 12T up to 200m to tip.

Clauchrie – Consents Unit - ECU00002001 (ref 074). SAC formally objected. Now going to Public Inquiry – DPEA – WIN-370-3 – it will be possible to watch the proceedings.

Craiginmoddie – amended to 14T upto max 200m in height – basically in area of ex-Hadyard Hill Extension – Energie Kontor – ECU00002080 – on-line public event available - https://www.energiekontor.co.uk/our-projects/craiginmoddie – sent in a couple of comments, and have now been made aware of the full consultation ECU00002196 – deadline extended to

4 April. Heavy Load access is proposed off Eldinton Terrace. Issues particular with turbines 1,2,3,4, and 5 re potential water contamination, noise and/or visual. ET gave update on visuals/overbearing/shadow flicker.

Carrick Forest – reduced to 13T upto 200m high inc Energy Storage System – ECU00002063 –scoping response sent. Recreational Enhancements indicated, and Online Public Information Event held. SPR have now sent info re Community Investment if consented to build. This needs to be discussed/consulted on. SPR sent a 'Gatecheck Report' in response to our EIA Scoping response. Various Questions answered.

Arecleoch Extension – 13T plus associated infra – Public Enquiry – *Cllr AC to check SAC*. **Kirk Hill** – planning extension granted to 2022 – appeal granted height now 115.5m. **Tralorg** – operational since 21 October 2020. Waiting for info from HMRC, funds available after this, still to organise paper trail issues and evaluations of distribution – *check status*. **Knockodhar** – 32T tip height upto 200m inc Energy Storage System. South side of Stinchar Valley. In Scoping ECU00002153 – sent response 27 November.

If members of the community have any comments regarding proposed windfarms, they should make their views, whether positive or negative, known to the CC as soon as possible, or direct them straight to the planning application.

5. Paths / Dailly Trails and Dalquharran

JF advised where self-closing gates might be suitable – all on Barony walk, one off the hill, one at Poundland/Glourie field, and one by the river section opposite Woodend. Will get quotes/compare, check with Rachel Shipley/SAC for contractors as well as Gateman Girvan.

JF to discuss with RS/SAC re possibility of repairing the Bridge at Drumburle to enable the circular walk to be completed. Could possibly utilise part of £25,000 for this project. Once viability checked will approach AP/Dalquharran for his input.

FdF indicated that the area behind the Memorial Park/Fish Bridge was in dire need of attention, and that before Spring growth becomes too evident brambles/scrub should be cut back. It was agreed in principle that an application for £500 should be made now from the Dailly Trails so that the work can be done as soon as possible.

6. Roads / Potholes / Gully Pots / 20 mph consultation
On-going - one-way system at Hadyard Terrace and 20-30mph speed limit improvements.

Secretary to discuss with Eddy McCulloch/ARA re siting of salt/grit bins.

Cllr AC had discussed with ARA flooding at the Kilkerran Station turnoff, poor drainage along Eldergrove/Maxwelston section of road, and Back Road.

FdF mentioned again about the state of the Gully Pots on Woodside – Secretary had notified ARA. Cllr AC would take this forward – concrete washing had been put down one, and there was also a broken/damaged pot, others were generally not clear.

Secretary had received an email/distributed from A77 Action Group re Phase 1 / STPR2 – they were asking for support of their response. All agreed that we should support as the A77 is in dire need of proper investment. Secretary to make response/deadline 31 March.

7. Hadyard Hill Community Fund Panel and Small Grant Fund Secretary asked whether in principle the CC should apply for a £10,000 grant for a Community Action Plan. The deadline for applying is 22 March, with the Panel meeting 17 May – the next Panel meeting is in September. After discussion, it was agreed 5 to 1 that we should apply. Secretary to make application. The whole process needs more discussion. In the meantime, when restrictions are lifted, we could have an Open Day to start the process. PW felt that the CC could take this forward, other members thought they could not give the required time/effort to do it justice. All understood that an Action Plan was needed in order to move forward for the good of the Community – however, we need input from the Community to do this. On-going.

Small Grants Fund – one from Dailly Scouts – for foot-operated hand-sanitizer pump, and litter pickers – £500 – unanimously approved. In principle application from Dailly Trails - £500 – unanimously agreed (per above).

8. Community Council Elections

Cllr AC advised that all attention is on the Budget taking place 4 March. He indicated that the Climate Change Group were involved in the Allotment Programme and if there is a requirement within the village, to get in touch.

Cllr AC would check with status of the repairs at the Miners Memorial (PW asked for the planter to be moved slightly), and also the status of the Plot behind the School.
