3. Minutes of Previous Meeting

Minutes of 07 April 2021 were proposed by PW, and seconded by FdF.

4. Police Report

5. Wind Farms – General

ET, FdF, HM and a few other concerned members of the public meet with journalist Sarah Hilley of the Ayrshire Post. She visited the village and various locations together with a photographer to document the concerns raised by the village and outlying residents re Windfarms, and Craiginmoddie in particular. The article was posted on 05 May 2021.

Per headings below (have taken away ones that have not been updated recently): **Knockcronal** – Scoping – ECU00002181 – response lodged - ex-Linfairn 12T up to 200m. **Clauchrie** – Consents Unit - ECU00002001 (ref 074). SAC formally objected. Public Enquiry – DPEA – WIN-370-3 – huge amount of work by local objectors.

Craiginmoddie – reduced to 14T up to max 200m – basically ex-Hadyard Hill Extension – Energie Kontor – ECU00002080 – https://www.energiekontor.co.uk/our-projects/craiginmoddie – sent in comments. Full consultation ECU00002196 – *deadline extended to 14 May – Secretary would send in the response in time*. Heavy Load access proposed off Eldinton Terrace/Issues particular with T1,2,3,4, and 5 re potential water contamination, noise, visual, overbearing, shadow flicker.

Carrick Forest – reduced to 13T up to 200m inc Energy Storage System – ECU00002063 – scoping response sent. Recreational Enhancements indicated, and Online Public Information Event held. SPR have now sent info re Community Investment if consented to build. This needs to be discussed/consulted on. SPR sent a 'Gatecheck Report' in response to our EIA Scoping response. Various Questions answered.

Arecleoch Extension – 13T plus associated infra – Public Enquiry – *DPEA* – *WIN-370-2* – *Objectors responses by 12 March, Applicant by 26 March* – *now with Reports to prepare for Scottish Ministers.*

Kirk Hill – planning extension granted to 2022 – height now 115.5m.

Tralorg – operational since 21 October 2020. *Awaiting update re funding*.

Knockodhar – 32T tip height up to 200m inc Energy Storage System. South side of Stinchar Valley. In Scoping ECU00002153 – sent response 27 November.

If members of the community have any comments regarding proposed windfarms, they should make their views, whether positive or negative, known to the CC as soon as possible, or direct them straight to the planning application.

6. Paths / Dailly Trails and Dalquharran

JF indicated that she had been in touch with a local fencer and was waiting to meet-up on location for the 3 self-closing gates. She would also try and obtain 2 other quotes. Secretary would get in touch with RS/SAC for an update on her discussion with AP/Dalquharran, JF would also be involved. Before being able to move forward with any project on the north side of the river, it was agreed that we need confirmation that there is a possibility of repairing the Bridge at Drumburle (Waulkmill Bridge), to make any circular route. Also waiting to hear whether a path audit would take place, generally thought to be a good idea to establish what needs to be done, and to timetable any works.

FdF confirmed that the cutting back of the river banking was delayed because of the time of year/bird nesting, etc. Will be done when appropriate.

7. Roads / Potholes / Gully Pots / 20 mph consultation

On-going – waiting for info re one-way system at Hadyard Terrace. Secretary had been in discussion with Cllr AC and ARA re the 20-30mph improvements as there seemed to have been some confusion. Hard landscaping had originally been agreed. Not everyone had been happy with this, but plans were drawn up and approved. Members felt that there must be some method of slowing the traffic, particularly at Eldinton Terrace. While we were discussing KB/ARA sent an email to Cllr AC agreeing to the flashing lights/signage/lining of the village instead of all the hard landscaping that had previously been agreed. However, members thought that the Bridge at Andy Lunny's should have the footpath widened, therefore narrowing the road, which would slow traffic. ARA will forward appropriate plans shortly.

Secretary would get in touch with Eddy McCulloch/ARA re siting of salt/grit bins.

Cllr AC has asked for the inspector/ARA to get in touch re signage in general, especially after the new UNESCO Biosphere signs are up (ARA had indicated we are in phase 2).

8. Hadyard Hill Community Fund Panel and Small Grant Fund

Secretary had received information from CARES re their support and grant application process – it would be forwarded for everyone to review and comment. If acceptable, then the application to HHCF for a £10,000 grant might not be necessary.

FdF had received a request from the Rural – they had received a grant in 2019 that they had not been able to use due to Covid restrictions. They requested to change the use to purchase the Rural Cookbook, one for each member, to enable them to use those recipes for Rural competitions. Unanimously agreed to the change.

SN raised a point to BS/Dailly Amateurs that funding could be made available for Security Lighting at the football pitch, if required. BS to check.

9. Community Council Elections

Cllr AC indicated that he had no further information – depends on restrictions being lifted. Secretary can confirm that an AGM is not necessary, however Accounts will have to be approved. This can be done at a regular meeting.

10. Councillor's Report

Cllr AC had been in touch with Tom Burns/SAC Estates, and confirms that the Plot behind the School went to the highest bidder, and was in the process of going through. During discussion, PW asked whether the community could have purchased the plot with HH funding. All agreed that this would probably have been possible. The issue was that the CC had not really been given the opportunity.

The Head Teacher at Girvan Academy would be leaving after the summer for Prestwick Academy. SN asked about Carrick Academy status, Cllr AC confirmed that the build was now on track.

PW asked whether there was any update on the situation re the appeal for Brunston conversion to a dwelling house. Cllr AC advised that he would be attending a Regulatory meeting where a decision would be made. Members did not understand the initial refusal.

11. Any Other Business

RBS On-line – PW had asked whether grant money could be forwarded on-line rather than by cheque. FdF had previously made enquiries about on-line banking for the CC account, but had not yet had time to investigate fully. All agreed that this was the best way forward, and FdF would start the process asap.
