### Minutes of Wednesday 07 July 2021 First Physical Meeting since 04 March 2020 Held in the Community Centre at 6.30pm

2. Declaration of Interest: John Whiteford – Windfarms

3. Minutes of Previous Meeting  
Minutes of 02 June 2021 were proposed by FdF, and seconded by PW.

4. Police Report

There were 7 incidents raised in the month of June with 3 crime reports being created of which all were detected:

Cllr AC advised that 2 quad bikes had been purchased through a joint effort between SAC and the Police, for use in rural areas – good for off the beaten track access, checking on fly-tipping, etc.

5. Wind Farms – General

Per headings below (have taken away ones that have not been updated recently):

**Clauchrie to Knockodhar overhead lines** – SPR - *waiting to see if going to ECU in Summer 2021.*

**Knockcronal** – Scoping – ECU00002181 – response lodged - ex-Linfairn 12T up to 200m. The proper consultation through the ECU is still to happen. *There had been a Webinar on 29 June – informative on how an area is chosen, overlaying of various constraints and forecasting of wind speeds.*

**Clauchrie** – Consents Unit - ECU00002001 (ref 074). SAC formally objected. Public Enquiry – DPEA – WIN-370-3 – huge amount of work by local objectors. *Still on-going with the Public Enquiry.*

**Craigmoddie** – reduced to 14T up to max 200m – basically ex-Hadyard Hill Extension – Energie Kontor. Full consultation ECU00002196 – response submitted to ECU. SAC will respond by about September. *ET advised that Allan Dorans MP and EnergieKontor had arranged to meet on site shortly. And, that Alan Edgar and Connie Lobhan/SAC would be making a site visit for visual impact, and visit 7 properties relating to water supply issues.*

**Carrick Forest** – reduced to 13T up to 200m inc Energy Storage System – ECU00002063 – scoping response sent. Recreational Enhancements indicated, and Online Public Information Event held. SPR have now sent info re Community Investment if consented to build. This needs to be discussed/consulted on. SPR sent a ‘Gatecheck Report’ in response to our EIA Scoping response. Various Questions answered.

**Arcleoch Extension** – 13T plus associated infra – Public Enquiry – DPEA – WIN-370-2 – now with Reporters to prepare for Scottish Ministers.

**Kirk Hill** – planning extension granted to 2022 – height now 115.5m.

**Tralorg** – operational since 21 October 2020. *Still waiting on Companies House/HMRC.*

**Knockodhar** – 32T tip height up to 200m inc Energy Storage System. South side of Stinchar Valley. In Scoping ECU00002153 – sent response 27 November.

**Kilgallioch** – the benefit fund had a closing date of 5 July, and they were looking for new directors for the wider area of benefit.

**Balunton** – a new proposal just north of Glentool – 7T, 200m.

**If members of the community have any comments regarding proposed windfarms, they should make their views, whether positive or negative, known to the CC as soon as possible, or direct them straight to the planning application.**

#### 6. Paths / Dailly Trails and Dalquharran

FdF advised that the quote for installing the self-closing gates would require additional funding, on top of the £1,500 received from Paths for All. Secretary had prepared an application for the Small Grants Fund, however after discussion it was agreed that we should approach the larger fund. Secretary to prepare an application, and speak with FS. Everyone felt that this had been outstanding for a long time and needed to be completed.

JF had met with AP/Dalquharran, Balcamie and RS/SAC to discuss possibilities on the Drumburle side, linking and connecting various paths. RS is in the process of checking with the engineers about Waulkmill Bridge, the banking is rather undercut and needs stabilising. Cllr AC reminded about the availability of our portion of the £25,000 VAT refund.

HD handed over additional markers to FdF/RT. Dailly Danners will walk the Barony Trail over the weekend - RT would check that there were sufficient directional markers, as there had been a few complaints about lack of markers. ET remarked that there had been a big increase in walker activity in that area.

PW asked about access through the football field and Brunston fields/bridges - JW would check with HDH/Bargany.

RT advised that one of the Barony Trails signs was missing off its metal plate – checking.

#### 7. Roads / Potholes / Gully Pots / 20 mph consultation

Cllr AC had been advised by ARA that the Vehicle Activated signs had been ordered and were in production. Currently works for installation would start mid-August. There were no specific dates yet for Dailly.

The Biosphere road signs had been installed – all thought they looked good, and HD would put a photo on FB. FdF reminded Cllr AC about the other various signs that were either damaged or unnecessary – Cllr AC to check with ARA.

BS asked about the road sweeper and NB indicated that the long in-pavement gully drain from about 84 Main Street going north had not been cleared for a long time - Cllr AC would check whether the sweepers were now back in action, and advise ARA about the drains.

Secretary had received various complaints about vegetation (Eldinton Terrace and Bridge/Main Street) and missing drain grids – these were being dealt with by ARA or SAC.

Nothing has yet been done about a one-way system at Hadyard Terrace.

Cllr AC had been in contact with KB/ARA about the condition of Back Road – on-going.

#### 8. Hadyard Hill Community Fund Panel and Small Grant Fund

Secretary advised that we were not successful re our CARES application, however they would help with the Invitation to Tender for an appropriate consultant to carry out the Community Action Plan. All agreed that a professional CAP would be necessary for any major funding applications. It would also focus the community. A Steering Group would be required – FdF, PW, JW, LM, and Secretary put themselves forward. They will be the link between the consultant and the community. Secretary to check CARES and FS about the way forward.

There were no SGF applications.

#### 9. Community Council Elections

Cllr AC advised that there might be info re Elections after the First Minister has indicated what might happen in August re opening-up. Secretary clarified the situation re the number of members. As we will have a vacancy (HD leaving) there is space for one co-optee, ie 9 members total. With the new Scheme we will be allowed 10 members. We can have several specialist co-optees. NB indicated that he would like to come onboard – Secretary to advertise the vacancy.

The Chair JW took the opportunity to thank Hilary for her contribution to the Community Council and Community in general, especially re the Facebook and Website. HD indicated that she will still attend to both remotely, until we have a replacement.

#### 10. Carrick Activity Centre

The Centre had been used again for Asymptomatic Testing, however the period was cut short because of an outbreak in Symington. The Centre also had to close due to one of the instructors testing positive. It is now back open.

#### 11. Councillor's Report

Cllr AC advised that he had had further discussion with Estates/SAC – appears that the Plot is returning to SAC, and might be available to the Community. After discussion, it was agreed that we should advise SAC of our interest. Various ideas were floated but this has to be discussed properly and could be part of the CAP. Secretary to send email to SAC.

Cllr AC advised that the 3 houses previously rejected at Wallacetown had now been passed by Planning.

SAC attended a meeting with the NFU and Andrew McFadzean of Balcohmie Farm, Maybole to discuss ways of promoting and supporting local farmers and locally produced product.

#### 12. Treasurer's Report

FdF advised that the accounts had been independently checked, and sent to SAC. Members had received a copy – proposed by FdF, and seconded by PW.

#### 13. Any Other Business

*Biosphere* – HD had received an email from them re information boards, we had talked about this sometime ago – Secretary to investigate.

*Dobbingstone Forestry* – Secretary had to resend our response from August 2020 – Scottish Forestry are only now assessing the case.

*Community Centre WiFi* – FdF wondered whether the booster had been installed for the WiFi in the Centre – Cllr AC would check.
